Environmental Objectives

InspireAll recognises that its use of energy has a direct impact on the environment and also accepts the potential to reduce tis effect while making the use of energy throughout our sites more efficient and cost effective. InspireAll is corporately committed to the following:

- Reduction in Co2 emissions by 2%. Therefore, showing a reduction in DEC, CRC and utility costs.
- External Audits Obtain ISO14001: 2015 accreditation
- Internal Audits Each site to have annual audit with no scores less than 60% achieved
- To achieve an overall recycle rate of 70%
- BMS upgrade programme to take place to improve overall buildings plant efficiency
- LED lighting replacement programme to continue to rollout across the portfolio

InspireAll will achieve these goals through the following methods:

- full implementation of corporate Environmental Management Plan
- monitoring of usage, load management and tariff negotiation
- daily monitoring and management of BMS systems
- maximisation of energy saving equipment and devices
- capital investment in energy efficient and green energy technologies
- improving staff awareness and involvement through training
- nominated 'Energy Champions' to lead on environmental issues, activity, training and housekeeping within Facilities
- contractors environmental policy to form part of the evaluation to become an approved supplier for InspireAll
- constantly seek environmentally friendly alternatives for all consumables
- employment of contractor to provide recycling services and ensure all waste is separated and sorted to minimise landfill
- Push Bike Allowance and Bike to Work scheme available for all staff
- Staff to have access to a loan to purchase a bike and be rewarded for cycling to work and sharing car journeys
- actively encouraging customers to support InspireAll's corporate policy, objectives and associated activities
