<p>Risk:</p> <ul style="list-style-type: none"> • Pinch areas • Entrances/Exits • Corridors/Circulation areas • Waiting areas • Face Coverings 	<p>Staff/Customers/Visitors and Contractors</p>	<p>While there are no longer any legal requirements for social distancing, we recommend encouraging customers to keep their distance from each other wherever possible, especially those who have not been fully vaccinated or may be at higher risk or are near people they do not live with.</p> <p>The capacity limits for indoor facilities are no longer in place, but we would again recommend a sensible approach (based on a risk assessment) to prevent overcrowding and allow space for those who wish to maintain some degree of social distancing and to respect personal space.</p> <p>From Friday 10 December, face coverings will become compulsory in most public indoor venues, such as cinemas, theatres and places of worship. There will be exemptions in venues where it is not practical to wear one, such as when you are eating, drinking or exercising. For that reason, face masks will not be required in hospitality settings. In-person working will be necessary in some cases to continue the effective and accessible delivery of some public services and private industries. If you need to continue to go into work, consider taking lateral flow tests regularly to manage your own risk and the risk to others. • You do not need to stay at a 2 metre distance; however, in order to minimise risk at a time of high prevalence, you should limit the close contact you have with those you do not usually live with, and increase close contact gradually.
